Organisations today are designing and implementing live blockchain applications in banking, equity trading, real estate, facility management, healthcare, supply change management, energy supply and land registry to name a few.


Blockchain technology is helping organizations reduce administrative overhead cost, speed up the transactional time and streamline processes.
